05-01 Call to order and Roll Call

As of Friday evening they had a registration total of 994.

05-03 Approval of Minutes for 2004 IAGSDC meetings

The Minutes of the 2004 IAGSDC Executive Board Meeting and 2004 IAGSDC General Meeting were approved as submitted.

05-04 Treasurer's Report

Brian Smith presented a detailed report of the financial condition of the IAGSDC. The Association is in good condition. Income was \$5,050.00. Expenses were \$5,394.00. The account balance as of 6/30/2005 was \$26,402.33.

It was moved & seconded to accept the proposed 2005-2006 Budget. Passed.

As a supporting challenge to Banner Dances, Bob Young offered again to match up to \$50 for every Banner Dance clubs may hold in 2005-2006.

05-05 Membership Report / Applications

05-08 Future Conventions

2008 Cleveland, OH (July 3-6, 2008) – 25th Anniversary Convention

The bid for 2009 was awarded to the DC Lambda Squares for May 21-24, 2009, in Washington, DC.

Bids were closed for the 2010 convention. Cities which will submit their bids to next year's Delegates are: Chicago, New York, Atlanta and Tucson.

Interest in 2011+ was expressed by Seattle, South Florida, San Antonio and Toronto.

05-09 Status Report on Rainbow Trust

Ralph Lorier reported that the current value of the Trust is \$58,470.. He expects that the Trust will last another 4-5 years. The Trust began in 1997 with a bequest from Joe Petersen in his Will. Since the inception of the Trust, \$103,745.39 has been given to the IAGSDC for distribution by the Petersen Fund Committee. In 2004-2005, \$13,687.62 was given to Petersen.

05-10 Report from the Petersen Fund Committee

Keith Gehrig reported that there is currently \$26,247.72 available for grant distribution. For the 2004-2005 fiscal year, Petersen awarded 20 grants in the amount of \$16,171.17.

05-11 Status Report on the All Join Hands Foundation, Ltd.

Gordon Macaw reported that the ending 2004 cash balance was \$29,225.01. The projected ending 2005 cash balance is \$24,467.44.

Projects of the Foundation for the past year have been:

Paying shipping costs of the Displays so that all clubs can afford to use them.

GCA Caller School

Trail-In Dance and Contra Dance in Santa Clara

05-12 Report from the Club Development Committee

Bob Hazen reported that the mission of the CDC is to outreach to the gay community to encourage new clubs for the IAGSDC. This includes festival, rodeos, and other events. Assistance is also offered to current clubs experiencing difficulties.

A town hall meeting is scheduled for Sunday afternoon to discuss the use of the new web site. A new IAGSDC brochure is being developed.

The IAGSDC Logo has been re-registered. It will be the only officially recognized version of the logo.

Clubs are encouraged to sign up for using the traveling Displays at Pride and other events.

05-14 Report from ARTS Dance

Scott Philips reported on the Alliance of Round Traditional and Square Dance committee (ARTS). He attends the Governing Board meetings as a representative of the IAGSDC. ARTS is dedicated to marketing dance to the general public. ARTS has done two surveys at the National Square Dance Conventions in Denver and Portland. IAGSDC has done the same survey at our Phoenix and Santa Clara conventions. The surveys show that while the general public has one perception of square dancers, the actual demographics are quite different. We are basically urban/suburban people, with college degrees and middle to upper income.

The IAGSDC survey shows that we are probably 10 year behind the straight dance community in the problem of decreased number of dancers, making promotion and recruiting ideas extremely important to us as well as to the other dance organization.

05-15 IAGSDC By-laws Change

Change Article III, Section 3, A:

A formal written application *and a set of bylaws* must be made to the Executive Board <u>60 days</u> prior to the annual Executive Board Meeting.

Moved and seconded to accept. PASSED

05-16 IAGSDC By-Laws Change

Moved and seconded to accept. FAILED.
