### **The Memorial Panels**

IN 1994 Freeman Stamper had a vision about the Memorial Panels. The first panel appeared at Stars and Stripes Forever in Washington D.C.

In the following two years two more panels were created and display frames were constructed. The panels were painted by Gene Boemer, an artist friend

of Freeman Stamper's, from Rehoboth Beach, Delaware. The frames were designed and constructed by George Fox of Capital City Squares in Sacramento California.

In 2001 Brian Smith and John McKinstry of Vancouver Canada created a database of every name on all three panels. A book is once again being placed next to the display at convention, in the hopes that when people place badges of those that have left us they will also add that name to the book. This will facilitate keeping the database up to date. This database also gives us something to fall back upon in the unlikely event that anything should ever happen to the panels.

The Panels have come to represent a powerful and moving reminder of how many people we have lost over the years. Every year when badges are added to the panel there is a certain catharsis that takes place during the ritual of placing a badge on the memorial panels. Also for just being able to look at the panels on display provides each and every one of us an opportunity to grieve and remember.

Thank you Freeman for giving us a way to remember.

## The Petersen Fund

#### WHAT IS THE PETERSEN FUND?

In 1995 Denver's Rocky Mountain Rainbeaus lost one of their valued members – Joe Petersen. Thanks to Joe's actions, his love of gay square dancing is continuing. Joe made a generous bequest in his will to perpetuate and promote gay square dancing. The monies Joe bequeathed were placed in the Rainbow Trust. The earnings from the Trust are made



Petersen Fund, which is the Petersen Committee. Immittee is composed of the Chair, the Administrator of st, and 3 members elected by Executive Board (the e Committee acts on club unds and awards grants. The

income from the Rainbow Trust is usually between \$12,000 – \$13,000 each year, from which Petersen grants are made.

## <u>PETERSEN GRANTS – WHAT AND</u> <u>HOW</u>

The purpose of the Petersen Fund, as per Joe's wishes, is to -

- Promote club growth and development through education, recruitment, and promotion.
- Assist in the establishment of new clubs.
- Promotion and advancement of Gay and Lesbian square dancing and by doing so, advancing the whole activity of square dancing.
- Informing non-dancers of the activity and its benefits.

Examples of past funding projects – In the years the Petersen Fund has been operating, here are samples of projects which have been funded. It is usual for the Committee to fully fund some parts of a request and only partially fund others.

- Recruiting: booth rental at pride festivals and street fairs; pride parade fees; advertising; printing of flyers and brochures; postage for mailings to prospective class members; caller fees and/or hall rental for live demos and recruiting dances.
- Starting new clubs: fund specific items needed in trying to establish a new club; reimburse an individual who uses personal funds to successfully start a new club (must be documented with receipts).
- Help struggling clubs get on sound footing: temporary help with caller expenses while a club works toward financial independence (usually only a one-year or less grant).

Examples or requests not funded -

- Expenses of regular club activities, which should be part of their operating budget.
- Purchase of sound systems.
- As there is a limit to available Petersen Funds, clubs in solid financial positions have had requests either denied or only partially funded.

How will your club's application be most successful – This can be best answered in two words: **BE SPECIFIC**!

The Committee can better evaluate your application if you are detailed. Requests that are too general and broad can maybe give the impression of a poorly thought out application.

- Avoid: "Advertising (et.al) (this includes postage)". Let us know what ads, how many, and the estimated cost per ad. Tell us how many mailings you propose and the estimated cost for each.
- Avoid: "Pride Festival Activities". Be specific as to booth rental, parade fees, printing flyers, etc.
- Avoid: "Expenses starting a new club": Detail the expenses. If you are requesting reimbursement for money already spent, be prepared to document it with receipts
- On the applications, fill in the club's financial position as completely as possible. If your club is currently struggling and wants help, indicate what you are trying to do to get back on solid footing.
- One of the main guiding factors of committee deliberations is "How many new dancers will the expenditure of these funds bring to the club
- Keep your request reasonable, along with good supporting information, and the committee is more apt to act favorably on your application.

WHERE TO FIND APPLICATION FORMS FOR PETERSEN GRANTS –

If you think your club could benefit from a Petersen grant, ask your club officers to look for that May 1, 2003, mailing mentioned above. Remind them that the deadline for mailing applications is **June 15, 2003**.

## 20th Annual IAGSDC® Convention July 3-6, 2003

A great option for late night relaxing and socializing will be at the Captain's Table Cabaret with live entertainment.

## **The Medallion Project**

In creating the Medallion Project, Freeman Stamper achieved the following goals:

 $\sim$  giving the individual dancer a simple, attainable goal that is judged by nothing other than participation

 $\sim$  giving the individual dancer control over attaining the goal so that alternatives can be woven into the process of achievement

 $\sim$  providing a goal that is realistic, but requires extraordinary effort

~ providing a reward that is tangible and

visually satisfying

 $\sim$  providing a spirit of great joy and a feeling of personal human worth in having achieved the goal

 $\sim$  creating a feeling of community and equality among those who have reached and are seeking to reach the same goal

 $\sim$  extending the convention attendance life of the dancer in order to provide significant convention attendees so that newer dancers feel the excitement of the mass

It does not take ten years to earn a medallion. It can be earned in nine years because they are counted from the beginning of the year, not the end (as is true when counting anniversaries). Additionally, since the conventions do not have to be consecutive, some dancers take longer than 10 years to earn a medallion. It is important to remember that conventions are being counted, not years.

Once again this year at the annual convention in San Diego another special group of people will be honored with a ten year medallion. In addition, as the IAGSDC<sup>®</sup> celebrates it's 20<sup>th</sup> Convention, a very special group of people will be attending their 20<sup>th</sup> Convention.

## Why go to an A&C Weekend?

So.....you're a new A2 or C1 dancer. You had a great time learning all those new moves. What's next? I suggest that your dancing skills would benefit greatly from your attending this year's A&C weekend, being held in Vancouver this October.

I've attended A&C weekends for a few years. My first was the weekend the El Camino Reelers hosted ("Shakedown Along the Fault") in Redwood City in 1997. I was scared to death at first....but I ended up having a terrific time!

The annual IAGSDC<sup>®</sup> convention is still one of the best places to build and "lock in" your skills at a new dance level. HOWEVER ... once you start dancing Advanced (or Challenge), there are good reasons to ALSO go to the annual gay & lesbian A&C fly-ins.

- At Convention, you're dancing with peers; many other people have recently graduated at the level you're dancing, or are generally comfortable at the level in the hall. It's fun, but it can be frustrating at times.

- At the A&C fly-in, the A2 halls are more likely to contain a lot of higher-level dancers. That means stronger squares with other dancers who will be very supportive of your attempts to master the level.

I've had very positive experiences at the A&C fly-ins, and have learned a lot of the "finer points" of A&C dancing there. It's also a smaller crowd, which makes the experience of dancing at a "freshly-learned" level a lot less scary.

Vancouver BC is an especially good place for a first A&C fly-in for new A2/C1 dancers. The local club ("Squares Across The Border") is exceptionally friendly. The exchange rate is low enough (in our favor) that a weekend in Vancouver is a terrific bargain for U.S. visitors. And Vancouver is not only beautiful, but is also very clean and safe. Oh! And you already know what it's like to dance to Anne, so at least one of the callers will be familiar to you. ©
