All Join Hands Foundation

All Join Hands Foundation, Ltd, is a nonprofit organization dedicated to supporting the funding of projects that will preserve and promote Gay, Lesbian, Bisexual, and Transgendered (GLBT) square dancing and other associated dance forms. The projects will protect the heritage of the activity and contribute to its growth, emphasizing the social, physical, and mental benefits of square dancing. All Join Hands Foundation will also increase public awareness, educate and inform the general public about preserving the art of square dancing, educate the public on GLBT square dancers, and educate the public about square dancing as an art form.

The idea for All Join Hands Foundation, Ltd. came from a brainstorming session by a group of dedicated square dancers who attended the Make Magic convention in Vancouver, British Columbia in 2001. In 1995, Joe Petersen, a member of the Rocky Mountain Rainbeaus in Denver, left provisions in his will to give money to the International Association of Gay Square Dance Clubs (IAGSDC[®]). The Petersen Fund was created as a result. Others have since inquired about how they could help further gay & lesbian square dancing.

All Join Hands Foundation, Ltd. was formed in 2002. It is registered with the United States Internal Revenue Service as a 501(c)(3) taxexempt corporation.

In October 2003, All Join Hands Foundation's first project was realized when it donated two additional travelling displays to the IAGSDC[®]. One will remain in Canada and the second will join the original display in travelling around the United States. The IAGSDC[®] also received a grant to cover the expense of transporting the display.

Currently All Join Hands Foundation is focusing its efforts on marketing and

promotion. Other projects include educational seminars, informative brochures, and public service announcements, but the progress does not need to stop here. Funding such projects is only the beginning of ways All Join Hands Foundation can positively influence GLBT square dancing. The possibilities are endless!

The key words to our goals are Preserve, Promote, and Educate! Please contact All Join Hands Foundation with ideas for specific projects that it can fund to advance its goals.

* Many employers have matching gifts programs that will match charitable donations of cash and stock. Some match gifts from retirees and employee spouses, and some even offer double and triple matches. There are some that do not have formal programs, but will still match donations. Proposed Amendments to the IAGSDC[®] Bylaws and Election Report

Four amendments to the IAGSDC[®] bylaws were proposed by the IAGSDC[®] Executive Committee for the General Membership's consideration. Two speakers pro and con were recognized to speak to each proposed bylaws change and the membership voted.

• The proposed amendment creating the position of Club Liaison Officer was passed.

- The proposed amendment eliminating the roll call at the Executive Committee Meeting was defeated.
- The proposed amendment changing the IAGSDC[®] convention licensing fee was passed.
- The proposed amendment to eliminate the role of the General Membership deciding Bylaws amendments was defeated.

Scott Parker then introduced the new IAGSDC[®] officers, including the new Club Liaison Officer.

Club Liason Officer

Let me introduce myself.

I'm Bob Hazen, a member of the Grand River Squares in Grand Rapids, MI and at the IAGSDC[®] convention in July I was elected to the board of the Association as YOUR Club Liaison Officer. This is a new position on the board and the roles are still being defined. Some of the projects that I am in charge of are; Club Development, with the help of Michael Spayd, Clubs at Risk, and improving the lines of communication between the clubs and the Association. What I hope the new office can provide is to bridge the gap between the clubs and the Association, and build a support network for our clubs.

If you need me to address a problem or issue please make sure you put Club Liaison Officer in the subject line so that it can be forwarded on to me.

First off, there is a new resource for the clubs that I would like see more members utilize. It is a Yahoo group named: IAGSDCpromote. It has a message posting that can be used to post ideas and answer each others questions (similar to the list server), add reminders to upcoming events on the calendar that can be emailed to members, and store files, such as advertising templates, dance ideas, and promotional fliers.

Let me address each of the issues to let you know where I'm coming from and why I think it is a good tool for the clubs to use.

-The message post is a great way to read threads of a messages so any replies to that post are kept with the originating message. If you have a problem, the solutions will be right there, without having to search through emails to know who has replied to the issue. And there is a search feature, if you want to find out if a club has had a similar problem you can search the archive to find what solutions they received. Let's admit it... we do tend to reinvent the wheel every time we have a problem, instead of using past experiences to help us through.

-The calendar feature is up and running and I have already placed upcoming rodeo events and pride events in the calendar. I'm hoping that this calendar will not necessarily be used to promote current club events but to remind clubs of promotional opportunities that they may be taking part in.

-The last feature is the file storage. How many times have we had to make up brochures for an event and no one knows where the last one came from or the first steps in coming up with a new one. I'm hoping that in time a log of dance fliers, promotional material and informational handouts will be on-line for clubs to check out, download, manipulate and use as their own. Take a template out of a file change the dates, location and club and viola a new handout in no time. Also good for clubs starting up to see what has been used and what information is good to have available.

(To avoid spam on the network I may need to verify who is trying to join before I accept a new member.)

To put together the promotional area of the group I need to collect items from our clubs. These include electronic files of brochures that have been produced, pictures that can be used for promotional purposes (need to have a release on file for subjects, forms are available in the Yahoo group), and any Internet links that can help clubs with ideas or promotional opportunities.

I am interested in finding out what YOU think my role should be. How can I help you out and what is it that has been missing in the communications between the clubs and the Association? Is there other resources that I should be aware of, or that you have found useful.

Thank you for taking the time to read this, I'm looking forward to working with all of you. Please share this information with your clubs and officers, discuss what your club issues are and what we can do as an Association to work together to solve them. Bob Hazen IAGSDC[®] Club Liaison Officer

<u>**Traveling Display</u>** - A professional Traveling Display made available to clubs for recruitment purposes.</u>

<u>Convention</u> <u>Advisory</u> <u>Committee</u> -Provides support and information sharing for clubs interested in hosting future conventions. Also provides support for current convention planning committees.

<u>Club Development Committee</u> - New committee designed to assist with club development issues including existing organizations as well as identifying potential new geographic areas.

<u>IAGSDC[®] Officers</u> - Volunteer staff to assist with administing the business of the IAGSDC[®] including Chair, Vice Chair, Secretary, Treasurer and the NEW Club Liaison Officer - Focus is to help and support clubs.


